6. Sealed bids must be submitted to the office of Kushe Rural Municipality Tharpu, Bharna, Jajarkot by hand before 12am on 2076/04/30. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00pm on 2076/04/30 at the office of KRM, Jajarkot. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of following table, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
