The bids will be opened in presence of Bidders' representatives who choose to attend on **1pm on 2025/05/28** at the office of Kushe Rural Municipality, Tharpu Bharna, Jajarkot, Karnali Province, Nepal. Bids must be valid for a period o **45 days** after bid opening and must be accopained by a bid security amounting to a minimum of NRs. 30,000 which shall be valid for 30 days beyond the validity period of the bid (i.e. Refer Clause ITB 20.1).
